Dr. Gene Ezell has been named a fellow in the North American Society of Health, Physical Education, Recreation, Sport and Dance Professionals. This organization recognizes outstanding professionals from within the allied professions of health education, physical education, recreation, sport and dance in North America. Dr. Ezell is a University of Tennessee National Alumni Professor of health and human performance at the University of Tennessee at Chattanooga.

Dr. Ezell was selected as United States Best College Health Educator of the Year by the American Association of Health Education. He was named Scholar of the Year by the Southern District Association for Health, Physical Education, Recreation and Dance and was appointed United States delegate to 12th World Congress on Health Education in Dublin, Ireland.

His research interests include health education, specifically HIV/AIDS prevention. Dr Ezell has written or co-written 15 books on health education.
